1. NAME OF THE TRUST:

The Trust hereby established shall be known as "SRI MAHALAKSHMI CHARITABLE TRUST"

2. REGISTERED OFFICE:

- 2.1 The Registered Office of the Trust shall be located in rental place at No. 233/3, Sri Mahalakshmi Nagar, Vadamadurai Road, Vellanampatty, Vedasandur Po, Vedasandur TK, Dindigul 624 708 or at any other place or places as may be decided by the Board of Trustees from time to time.
- 2.2. The Trust may open additional offices or branches at any other place or places as it may think fit for the operation of the Trust. However, all additional offices or branches that may be opened from time to time shall function only as a Branch Office of the Trust.

3. OBJECTIVES OF THE TRUST:

The prime purpose of the Trust is to establish a fund, infrastructure and setup for the beneficial promotion and propagation of knowledge in the field of Education, Agriculture, Medicine, Engineering and for socio – economic development in the rural and urban areas. With these objects in view the Trust may carry out all or any of the following functions.

A. EDUCATIONAL:

- ai) To establish, maintain, run, develop, improve, extent and to aid and assist in the establishment, maintenance, development, improvement, extension of educational institutions of such as CBSE Schools, kinder Gardens, Primary Schools, Matriculation Schools, Higher Secondary Schools, Colleges for arts, science medicine, nursing, para medical, engineering, electrical, electronic other training schools and hostels for the benefit of students and to award scholarship for the study, research and apprenticeship for all or any of the said purposes.
- aii) To get approval from Government of India and Government of Tamilnadu as necessary and run the educational institutions under the Trust.
- aiii) To start and maintain training centers of different technical skills like sports academy, computer training, typing, tailoring, handicrafts work, Industrial training Institute of the ordinary and technologically highly sophisticated kinds etc., and to provide such institutions facilities without any discrimination as caste, creed, sex or nationality.
- aiv) To develop rural employment and vocational training activities as part of this trust as integrated socio-economic cultural development programs.

B. MEDICAL:

- bi) To run, maintain or assist any medical institution, nursing home or clinics or to grant assistance to needy and indigent persons for meeting the cost of medical treatment.
- bii) To participate in the campaign against poverty, diseases like STD, AIDS drug use and alcoholism, female infanticide and to organize programs that would rehabilitate, help them to organize themselves to face these evils and to promote structures that would safeguard the society from such evils.
- biii) To Organize rural and urban health programs and to conduct health camps, health screening and health education Programs.

C. ENVIRONMENT:

- ci) To Promote and protect environment public sanitation and work towards achieving a safe and health environment.
- cii) To ensure Environmental Sustainability, access to safe drinking water, promote awareness about pollution, increase the land area covered by forest and protect ozone layer.

D. RELIEF OF THE POOR:

di) To give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms or meals for the poor and indigent.

- dil) To Undertake and extend various social service activities, emergency services, assistance and referral service in rural and urban areas irrespective of caste, creed or colour.
- diii) To Provide a shelter home for the destitute, orphans, and abandoned, mentally retarded, widows and deserted and to educate or train them in trades and skills for ensuring their self-reliance

- ev) To promote enterprises involving combination of exploration and identification of livelihood activities that can be upgraded through collective efforts of community actors.
- evi) To publish books, booklets, magazines, newsletter, pamphlets, etc., without any profit motive to develop love and faith towards human equality and to make them available to the public.
- evii) To aid help and promote self-help groups/savings and credit registered and unregistered groups including constitution of natural benefit /revolving fund activities to help and serve the poor and for strengthening the village economy.
- eviii) To organize groups, committees and fair price shops for the benefit of the rural poor and To provide materials, equipment and other required facilities for construction of low cost or other housing construction or such other activities.
- eix) To act as a resource center for Rural Development and co-ordinate with Government agencies or other organizations to conduct research, training, workshop to develop appropriate technologies benefiting the economy and the environment.
- ex) To raise funds by way of subscription, donations from the public and social organizations, Government and quasi Govt. agencies interested in the herbal medicine.
- exi) To Secure funds and Loan from Government, Non-Government Institution, Financial Institutions and other Funding agencies with in India or Outside India to provide the same as loan to the members of the Self Help Groups with or with out interest so as to enable the members of the Self Help Groups to utilize such funds for Income generation and other livelihood activities.

- 4.2 The total strength of the Board of Trustees shall now be EIGHTEEN and their term of the First Board of Trustees shall be life term unless removed as mentioned in clause 4.5. The Board of Trustees of the trust may co-opt additional Trustees as and when suitable persons are spotted out by them who can contribute to the attainment of the objectives of the Trust and their term shall be fixed by the Board of Trustees. Any additional Trustees shall be appointed by the Board of Trustees with two third of majority.
- 4.3 The appointments for the posts in the managing committee of the trust shall be once in three years. In the event of resignation or prolong illness or death of a trustee of the above posts, any other trustee shall be appointed on the post(s) as decided by the Board of Trustees.
- 4.4 The Trustees shall nominate any person with the consent of the Board of Trustees as their nominee to become as a trustee after their death. In case long absence, inability to discharge duties due to prolonged illness, resignation etc, of any trustee or Trustees, the Board of Trustees shall first consider the nominee of the trustee to appoint in his or her or their place. The Board of Trustees has the power to nominate suitable person or persons in his or her or their place, if none of the person is nominated by the trustee, after issuing notice to the legal heirs of concerned Trustee. register has to be maintained and updated for every financial year and signed by all the trustees with witness and it is to be maintained at the registered office of the trust.

- 4.5 The Board of Trustees shall have the power to remove any Trustee or Trustees on reasons of involvement in any unlawful and unethical activities or acting against the interest of the Trust, after serving a show cause notice in this regard. Before such removal, the Board should ensure sufficient recorded evidence in paper with witness. The show cause notice should be served through registered post with acknowledgement. If no reply is received from the trustee or the explanations are not sufficient to close the show cause notice, the Board of Trustees shall pass a resolution and record the removal of the Trustee after giving a period of 6 months from the date of service of last notice. This removal should also be communicated to the trustee by registered post with acknowledgement.
- 4.6 All matters related to appointment, renomination, removal etc, of any trustee/trustees shall be decided with the consent of 2/3rd majority of the trustees.

5. POWERS AND RESPONSIBILITIES OF THE BOARD OF TRUSTEES:

For the accomplishment of the aims and objectives of the Trust as expressed in this deed, the following powers and responsibilities are expressly conferred on the Trustees.

- 5.1. To enter into partnership agreements/contracts with like minded organization for undertaking innovative and need based action programs/projects on a long term hasis.
- 5.2 To form committees, sub-committees etc., from among the members of the Board or along with others who are specialized in the respective fields as and when need arises and assign duties and Seek suggestions for effective functioning of the Trust
- 5.3. To form working group comprising members from the Board of Trustees and senior professionals heading different wings or units of trust activities to ensure a participatory style of management and to provide an organic link between the organizations and activities to facilitate two way communications and to make the activities of the trust transparent.
- 5.4. To frame such rules and regulations for the management of the Trust and evolve systems and procedures for the administration of projects or programs and institutions set by the trust as they may Think fit, and to alter and vary the same from time to time and to make new rules and regulations.
- 5.5. To open or close any or all the additional offices or Branch Offices of the Trust for reasons the Trustees may think fit, by way passing resolutions.
- 5.6. To purchase or contract on hire or hire out or take on lease or lease out or sell or mortgage or exchange partially or fully any movable or immovable properties, equipments, vehicles and articles and construct buildings and infrastructure facilities and carry out other improvements there for all or any of the purpose of the trust at such price, cost or rent and on such terms and conditions and for such period and with or without option for renewal as the Trustees may think fit.

5.7. To invest funds from time to time in such securities and in such manner, as may be deemed fit, and to alter or vary the investment from time to time to

realize the investments. No investment should be made which would violate the provisions of Sec.11 (5) or such other provisions of the Income Tax Act, 1961.

- 5.8. To reimburse themselves or pay and discharge out of the funds or any property of the Trust, all out of pocket expenses properly incurred in the execution of the Trust activities. If any Trustee offers his/her consultancy services in any project or activity of the Trust or in any institutions set up by the Trust either full time or part time, he/she may be compensated with a reasonable fee for the time devoted to the Trust
- 5.9. To raise loan that may be required from time to time by the Trust for its operation and the realization of the objects of the Trust on such terms and conditions and for such period as the Trustees may think fit.

6. THE ROLE OF MANAGING COMMITTEE:

- 6.1. To receive such terms and conditions as they may deem fit donations, gifts subscriptions, fees, sponsorship, covenants and contributions in cash and/or kind from the public, companies/commercial firms, development organizations, institutions, Governmental and quasi-Governmental agencies and similar bodies in and outside India for the furtherance of the aforesaid objects of the Trust.
- 6.2. To organize fund raising events locally and outside through sponsored events, campaigns and other legally permissible means for the effective execution of programs/activities.
- 6.3. To appoint / contract / terminate / re-appoint Executives, Professionals, Advisers and other staff on such salary/honorarium/fees and on such terms and conditions as Trustees may think fit.
- 6.4. To sue against any activity of threat to the Trust properties and activities so as to safeguard the rights of the members of the and to ensure that the benefits out of the Trust reach the constituencies. The power to sue or to be sued rests with the Managing Committee.
- 6.5. To carry out day to day administration and to disburse salaries, wages, rent, remuneration and for repair, maintenance and other expenses on buildings, equipments etc., relating to the Trust and its activities or other affairs.
- 6.6. To vest such powers as specified above in the Managing Committee for the execution of the Trust activities by way of resolutions passed by either by circulation or at a meeting by the Board of Trustees.
- 6.7. The Managing Committee shall also carry out Executives Functions of the Trust for all administrative purposes.

The powers enumerated in clause 5 & 6 supra shall be exercised by the Board of Trustees subject to their satisfying the conditions laid down under section 11 to 13 and 60 to 63 of the Income Tax Act, 1961 as amended from time to time so that the income of the Trust shall become exempted from Income Tax for each and every assessment year.

7. MEETINGS:

- 7.1. In addition to the annual meeting, the Board of Trustees may meet from time to time as and when necessary with a notice of seven days in writing with acknowledgement.
- 7.2. The meeting shall be convened and presided over by the President as Chairman of the Meeting. In his/her absence, any other Trustee chosen by the members of the Trust shall preside over that particular meeting.
- 7.3. Two third of the Board members shall constitute the quorum.
- 7.4. All decisions shall be carried out by the majority decision of the Board but in the event of equal votes the Chairman shall have the casting vote.
- 7.5. The Board may at any time call for an extra-ordinary meeting within three days after the receipts of requisition in writing from at least three members of the Board. However, the president is empowered to call for any extra-ordinary meeting of the Board without a requisition from other members of the Board and such meeting shall be intimated to the members at least one day before the appointed day.
- 7.6. Any resolution in writing signed by all the Trustees shall be binding on the Board as though it has been passed at a meeting of the Board of Trustees.
- 7.7. The Trustees shall cause the proper recording of the minutes of all the meeting of the Board of Trustees.
- 7.8. The Managing Trustee may invite any specialist or others interested in the works of the Trust to attend the Board meeting but they shall not be entitled to vote thereat.
- 7.9. In exceptional circumstances, the board of trustees shall conduct the proceedings of the meeting through mails, circulars or writing.

8. ACCOUNTS:-

- 8.1. The Trustees shall open and maintain accounts in any Nationalized or Scheduled Bank(s) and the same shall be jointly operated by the president along with anyone nominated by the Board of trustees.
- 8.2. The Board of Trustees shall cause true and correct accounts for all receipts and expenditure on behalf of the Trust and any other institutions or projects run by the Trust.
- 8.3. The Trustees shall be indemnified against any expenses or losses incurred or suffered or any payments made by them in the administration of the Trust and such expenses and losses and payments shall be borne by the Trust and none of the Trustees shall in any way be made liable personally or made responsible for the same.
- 8.4. The accounting year of the Trust shall be from April to March.
- 8.5. The accounts of the Trust shall be audited by a qualified Chartered Accountant who shall be appointed in the Annual Board Meeting.

9. AMENDMENTS:

- 9.1 The Board of Trustees shall be at liberty to add or alter or delete any of the provisions of this Deed of the Trust and these amendments will not change the basic characters of the Trust. No such amendments which may prove to be repugnant to the provisions of section 2(15), 11, 12, 13, and 80G of the Income Tax Act 1961 shall be made
- 9.2 Any amendment to the Trust deed shall be carried out only with the approval Of the Commissioner of Income Tax having jurisdiction of the trust.

10. DECLARATION:

- 10.1 This Trust is a Public Charitable Trust to work for the cause of upliftment of general public without any restriction as to caste, greed and Religion and Sex.
- 10.2. The Trust shall be irrevocable.
- 10.3. It is hereby declared that no benefit accrued shall ensure either directly or indirectly to the Trustees.
- 10.4. The funds of the Trust shall be utilized solely towards the objects of the Trust and no portion of it shall be used for payment to trustees by way of profit, dividend, interest etc., excepting the reimbursement of the expenses and reasonable remuneration for the services rendered.
- 10.5. The benefits of the Trust shall be open to all irrespective of caste, creed and religion.
- 10.6. No activities of the Trust shall be carried out anywhere outside India neither with the objectivity nor with earning profit.
- The trust will not function in the nature of conducting any business activity with the profit motive.
- 10.8. In the event of the dissolution of this Trust the entire Trust funds also corpus fund shall be realized and first be used for payment of liabilities of the Trust.
